TERMS & CONDITIONS

Cancellation Policy

Once Attendee registers for the Retreat, we make extensive arrangements and investments while anticipating their tuition and attendance, and, in the case of their cancellation, we incur significant administration hassles and expenses. Given this fact, if Attendee does not cancel their reservation under the following guidelines they may incur a cancellation fee*:

1. If you cancel **90 days prior** to your retreat, there is no cancellation fee.
2. If you cancel between **60-89 days before** your retreat, there will be a **50% cancellation fee**, which can be used as a credit towards a future stay within one year.
3. If you cancel **under 60 days** before your retreat or **do not show**, a **100% cancellation** fee is incurred with no credit.

We highly suggest communicating with us to cancel your retreat at least 90 days before your retreat to avoid any fees.

* The fee will be charged to the same credit card used during registration.

* Cancellation fee refers to the cost of the entire program/retreat that the Attendee registered for.

* Peaceful Meadow Retreat Center, Lana Sackwild & David Jay Brown reserve the right to cancel any program at any time. In this event, you will be given a complete refund.
